SHOW REQUIREMENTS/INFORMATION

1. A negative Coggins within the past 12 months is required for **ANY** horse coming onto the show grounds. Please send a copy of Coggins with your entry form. Any horse without proof of negative Coggins will not be allowed on the show grounds. **FYI: Horse's name on the entry form MUST MATCH the horse's name on the Coggins.**
2. **Signatures:** All entries must have the required signatures (see page 3 of the Entry Form).
3. Entry fees must accompany the Entry Form - make check payable to Fort Worth Dressage Club.
4. Entries are limited and will be accepted in the order in which they are received. Entries received after the closing date will be accepted based on space availability - a late fee of \$10.00 per horse/rider combination will apply. Entries must be received no later than 5 pm, Thursday, June 6, 2019.
5. **Refunds:** Entry fees will be refunded, minus office fee, if cancellation is received before the closing date.
6. **STALLS:** There are a limited number of stalls available at \$30.00. **YOU MUST CALL SHOW SECRETARY TO RESERVE A STALL.** A separate check is required for the stall fee - payable to Willow Draw.
